**ORDINANCE SETTING TAX RATE FOR THE YEAR 2022 FOR
THE CITY OF SPLENDORA, TEXAS**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SPLENDORA,
TEXAS:**

THAT the tax rate be and the same is hereby set as follows:

Maintenance and Operations3010 Per \$100
Interest and Sinking Fund0413 Per \$100
Total.....	.3423 Per \$100

On the One Hundred valuation of all property of every kind and character placed on the Tax Rolls of the City of Splendor, Texas, for the year 2022.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE TAX RATE WILL EFFECTIVELY BE RAISED BY 47.77% AND WILL INCREASE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$16.50.
